NEW RULES (2023 - 2027)

**To:**Albanian Judo Federation, Bosnia and Herzegovina Judo Federation, Bulgarian Judo Federation, Hellenic Judo Federation, Kosovo Judo Federation, Macedonian Judo Federation, Montenegro Judo Federation, Romanian Judo Federation, Serbian Judo Federation, Turkish Judo Federation, Cyprus Judo Federation, Moldova Judo Federation

As the Balkan judo union, the decisions taken after the election in 2022 and at the meeting are given below.

- 1- Balkan judo union elections will be held every 5 years from now on. (first selection in the first competition of 2027)
- 2- The Balkan judo union, which has been governed by protocol until now, will be governed by status from now on. After 2023, it will be governed by statute.
- 3- Now all countries will have the right to participate with 4 athletes in each weight.
- 4- The daily fee will be 70 euros. A total of 140 euros per person to be paid. 2 days stay will be mandatory.
- 5- The board of directors of the Balkan Judo Union will be paid 300 euros per person. In addition, a 150 euro road fee will be paid. A total of 450 euros will be paid. Accommodation for BJA board members will be free of charge.
- 6- New countries have joined the Balkan judo union. Moldova participated in the matches for the first time. The participation of new countries is expected. ( SLOVENIA CROATIA )
- 7- It is planned to hold referee seminars and trainer seminars every year. There will also be joint training camps.
- 8- Countries can have 2 members on the BJA Board of Directors, but they will have one voting right.
- 9- only athletes will pay a participation fee of 20 euros from 2023. ( 10 euro BJA 10 euro for organization )
- 10- The countries that will make the Balkan championship have to pay 500 euros to the Balkan Judo Federation
- 11-2 referee from each country will be paid 100 Euros if it is IJF or EJU.
- 12- As the Balkan judo union, we are entering a stronger year. Therefore, the competitions will now be much more crowded. For this, the organizing countries have much more responsibilities. In order for the matches to be much more regular, the duties of the referees are very important. For this reason, the organizing countries should appoint at least 3 tatami and at least 10 referees. Each tatami must have at least 4 referees in the competition.
- 13- Countries that cannot provide this situation should notify at least 15 days in advance. In this case, BJA will call an arbitrator in consultation with other countries. Accommodation fee of the invited referees will be covered by the country of the competition.
